Convening the Meeting

Whitewater Valley Presbytery met by video conference for a stated meeting on August 7, 2021. The Moderator, Ruling Elder Mike Whitfield, called the meeting to order at 10:00 a.m. from the sanctuary of Irvington Presbyterian Church, Indianapolis.

The Moderator opened the meeting with prayer.

The following information was used to formulate this recommendation:

1. The full-time median salary* of PC(USA) pastors rose 1.5% for the subject reporting period. The Pastor Support Subcommittee uses 80% of the published median (\$62,100-rounded up to nearest \$1,000) to set the base compensation minimum for full-time pastors in the presbytery.

*The Board of Pensions of the Presbyterian Church (U.S.A.) annually tabulates the median and average effective salary information reported to it for minister members of the benefits Plan who are serving U.S. congregations. The median salary is generally considered more representative than the average salary, since it is less influenced by the very high or very low salaries.

2. The Pastor Support Subcommittee applies an increase or decrease to the full-time median salary minimum using data provided by The Bureau of Labor Statistics (www.bls.gov) Consumer Price Index (CPI)-Midwest Urban Report. A 3-year rolling average is applied to the CPI reporting period (2018-2021) to offset unusual spikes in the reported percentage. The data reflects an increase of 1.91% for the subject period.

Proposed 2022 Mission Operations and Mission Focus Units Budgets

Ruling Elder Greg Maier, on behalf of the Finance Committee and the Coordinating Council, presented a first reading of the proposed 2022 Mission Operations and Mission Focus Units Budgets. The budgets will be presented for action at the November stated meeting of presbytery.

Administrative Commission for St. Andrew Presbyterian Church, Indianapolis

The Rev. Deborah Mitchell presented the report of the Administrative Commission for St. Andrew Presbyterian Church, Indianapolis.

The St. Andrew Administrative Commission recommended, and Presbytery granted preliminary approval for the St. Andrew property to be transferred to Witherspoon Presbyterian Church. The Administrative Commission will request final approval of this proposal at the November Presbytery meeting. In the meantime, the Presbytery, working through the Administrative Commission and the Board of Directors, will determine further details, including a formal timeline and how the proceeds from the sale of the current Witherspoon property will be handled.

The Witherspoon session shared with the Administrative Commission that they anticipate needing most of the proceeds from the sale of the current Witherspoon property to cover the costs of moving, and to address deferred maintenance and structural repairs (asbestos cleanup, HVAC upgrades, parking lot repairs, and more). The Presbytery's preliminary approval allows Witherspoon to seek possible additional or alternative funding through grants and financing.

The Commission shared its belief that this is the best use of the property for the community, the Presbytery, the legacy of St. Andrew, and for the Body of Christ. While multiple parties expressed interest in purchasing or leasing the St. Andrew property, none of the current proposals, except for Witherspoon's proposal, would have kept the property primarily as a church. The Administrative Commission ruled out those who were not able to purchase the property for a fair price. The remaining interested parties wished to use the property for a school, social services, and/or a space for community organizations and services.

After meeting with representatives from Witherspoon and hearing their plans and visions for their congregation and the ministries that could be expanded, strengthened, or created in moving to the St. Andrew property, the Commission concurred that transferring the property to Witherspoon is the best use of this property. Witherspoon's congregation has prayerfully considered this plan, has excitedly endorsed it, and is ready to move forward to energetically work on seeing it into being.

Close of Business

The Stated Clerk reported that no new business had been requested.

The Moderator thanked the session, pastor, staff, and members of Irvington Presbyterian Church, Indianapolis for hosting the meeting and for the use of their livestreaming facilities and the technical services of Craig Shaw.

The Moderator announced that the next stated meeting would be on Wednesday, November 3, 2021, and convene at 10:00 a.m.

There being no further business, the Moderator declared the meeting adjourned without objection at the close of worship.

Motion by Sue Whitaker to approve designating budgeted funds for the February and May assembly meetings lunch to One Great Hour of Sharing and Pentecost. Ramona Dale seconded; the motion passed.

The council discerned returning to in-person or continuing with a virtual (Zoom) meeting for June 23, 2021. After discussion, consensus is to continue virtual meetings.

Mike Whitfield provided the Assembly Moderator's Report. Mike reported on the excitement around the examination of four candidates for ordination, other topics and the worship service docketed for the May 5 presbytery assembly.

Barry Sumner and Jennifer Linville presented the Hispanic Ministries Lead Team (HMLT) 2021 budget to Council for approval. Barry discussed the background and almost 20-year history of the presbytery HMLT ministry locally and internationally. Nancy Frick opened a period for questions. Alan Thames requested additional information about the funding sent directly to the Presbytery of Riviera Maya. Alan Thames reported a request from the Presbytery Board of Directors (BOD) to form a task force to work on the details of Pyoca's move to an independent corporation and 501(c)(3) organization. The task force will include two members of the BOD, two members from Council

and will be staffed by Alan Thames and Eric Herzog. Council members Max Muska and Trish Lisa agreed to serve reporting back to Council.

[Community Engagement and Mission & Partnership Work Groups exited the Council plenary meeting to participate in 30-minute virtual breakout sessions.] [Council reconvenes]

Ramona Dale reported for Community Engagement. The work group discussed the results of the recent surveys of pastors and clerks. The team was pleased with the feedback and a subgroup of 3 members will be assembling the data collected and reporting results back to Council.

Wally Wilson reported for Mission & Partnership. The work group made direct contact with several churches and experienced mixed results. Feedback from the churches contacted included a desire to see actions from the calls, surveys, etc. generated by the presbytery. Regarding participation, there was a consensus of exhaustion at the churches and that surveys, calls, etc. was just one more thing to accomplish. The Council received and updated report of grant awards from the Council Emergency Technology Grant Fund. The fund has disbursed \$22k and has a \$13k balance available for this ongoing work.

June 23, 2021

Max Muska updated Council on the progress and reasoning behind the Pyoca transition to a separate organization. Alan Thames discussed next steps.

Second Deb Mitchell. Approved

Report from Community Engagement Work Group - Mona Dale Mona provided an update on progress by the work group resulting from survey responses received from pastors and clerks. Working with presbytery staff on closed social media groups specific to communications for these groups. Coordination with the finance committee for inperson training on administration and finance for churches is in development.

Report from Personnel Committee - Trish Lisa

Alan Thames provided an update on the Committee for Administrative Review. Committee composition includes Jan DeVries (Honorably Retired Minster of Word and Sacrament), Martha Nommay (Second Presbyterian Church, Indianapolis) and John Purcell (Northminster Presbyterian Church, Indianapolis)

Nancy Frick recommended the formation of a task force to address concerns relating to balancing the presentation of confidential issues while maintain transparency to the Coordinating Council.

Asked that Presbytery Assembly address issues of Pastor's Self-care, how to best lead in this time, and church finances. Mike talked about the upcoming service of Lament and Hope at the Presbytery Assembly on February 6th. Sharing hope for the future

Eric reported that they are getting organized with knowing CREs, Designated Pastors, and finding new ways to be of support to them

Jon reported that the MIF for the Korean Presbyterian Church of Indianapolis was approved by the team and made the motion that it be approved by COM. **Passed**!

The team added names of Validated Ministers to the list of those already known, will get contact information for these ministers.

March 24, 2021

Kelly Spencer: Kelly is a Lakefellow at Second Presbyterian and is seeking Ordination in the PC(USA). Rev. Chris Henry was with Kelly for the interview. After her interview, we dismissed Kelly and Chris to the virtual "room" and held a lengthy discussion on BOO requirements for ordination. Moved to use G. 2.0610 at the May 5th Presbytery Assembly to Recommend Kelly Spencer for ordination and approve exemption of year long candidacy with ³/₄ vote of the Assembly. She has made it a part of her prayer life to visit sanctuaries (recently, especially in Richmond) and then picture as many congregations gathering to worship in these spaces as possible every Sunday, so she can remember the larger Body of Christ in her prayers. Pastor LydiaGrace's current favorite hymn is "O Love that Wilt Not Let me go," favorite food is her Lola's pilipino adobo, and favorite person (no offense to her sweet husband of 6 years, Dr. Jonathon George Gray, her 5 sisters, or her father the Rev. He has additional studies at the University of Southern California, Harvard Divinity School, and New York Theological Seminary. Martin is married to Sandy, a public school educator working as a District Instructional Coach for the Fort Wayne Community Schools. They share life with their son and a bunch of pets.

Ruling Elder Carla Beard is a ruling elder at First Presbyterian Church in Connersville, where she has served as Clerk of Session for 18 of the last 19 years. August 2021 Financial Results

- Mission Operations Ministry Fund
 - The fund ended the fiscal period with a surplus of \$130,434. This surplus balance will be reduced as quarterly disbursements are anticipated to exceed revenue for the remainder of the year. Per capita gifts are tracking close to estimates thank you! with operating ministry expenses for the leadership, office operations and reimbursements groups at/below budget estimates for the period.
- Mission Focus Units Fund
 - The fund ended the fiscal period with surplus of \$13,902 (balance is not reflecting mission partners accrued support of \$8,962 disbursed during September 2021).
 - Total resources for shared (basic) mission are tracking close to budget projections and above the prior year results for this period (\$2,350). Presbytery shared mission receipts reporting at 63% of total budget estimates compares favorably to 53% budget-receipts for this period in 2020. The finance committee is grateful for your gifts and celebrates these better-than-anticipated results.

Final Report of the St. Andrew Administrative Commission

The St. Andrew Administrative Commission (SAAC) recommends that the Presbytery grant final approval for the St. Andrew property to be transferred to Witherspoon Presbyterian Church as of December 1st, 2021. Since the preliminary approval granted at the August Presbytery Assembly, a task force has been established consisting of Witherspoon members, and Board of Directors and Coordinating Council members, which will coordinate the sale of Witherspoon's current property.

The SAAC has provided an appraisal, and a commercial and environmental inspection of the St. Andrew Property. The SAAC has resolved the contracts with existing building tenants of St. Andrew.

The SAAC continues to be inspired by the promise that development of the new "Imani" campus of Witherspoon will bless the neighborhood and glorify God. This is a bold, innovative, and inspired plan for life of the Presbytery and the Body of Christ. It demonstrates that, "although we haven't always done it this way", the people of Witherspoon and this Presbytery are indeed "Reformed, always reforming."

With a positive vote of this assembly for the final approval of transfer, the work of SAAC will be complete when the property is transferred to Witherspoon. With the Presbytery's approval the SAAC will be dissolved on December 1, 2021.

THE CROSS OF THE COVENANTS

MODERATOR'S CROSS THE PRESBYTERY OF WHITEWATER VALLEY

The beautiful silver cross worn by the Moderator of the Presbytery of Whitewater Valley was originally given to the Wabash Valley Presbytery by the Session of the Westminster United Presbyterian Church of Fort Wayne, at the January meeting in 1967. The tradition of it being worn by the Moderator continued with the organization of the Presbytery of Whitewater Valley.

This "Cross of the Covenants" was designed by the Rev. William Simmons, who was a pastor of the Ligonier Presbyterian Church. He had designed it while he was pastor of a church in Florida.



The New Covenant is symbolized by the Cross. The Old Covenant is symbolized by the Star of David. Both symbols are united by the circle, which calls to mind our Scottish Presbyterian heritage through the symbol of the God who has no beginning and no end.

Mr. Simmons told the story of the Jewish jeweler who was asked to make the cross. When he saw the design, he burst into tears. When asked why he was so upset, he answered, "If Christians in Germany during the time of Hitler had felt this way, perhaps my parents would still be alive."

The scriptures contain two Covenants, the Old and the New Testament, and each is incomplete without the other.

Mister/Madame Moderator, may you wear this Cross of the Covenants, always remembering the beauty and significance of the Old and New Testaments, our great Scottish Presbyterian heritage, and the influence of the Holy Spirit in your life and in the mission and ministry of the congregations of this Presbytery. May God bless you as you seek to discern how God would be leading us in the year ahead.

I believe in God, the Father, in Jesus Christ, his only son, and the Holy Spirit: co-equal and coeternal. I believe that Jesus came to earth, fully God and fully man, and died on a cross so that every person who believes in him can spend eternity with God. I believe that God's kingdom of peace and justice is both already here and not yet come. As the promised Messiah (Isaiah 9), Christ incarnates God's reign. In dying and rising, Christ has already defeated death and sin (Romans 8, Revelation 5), but we are still waiting for the day when this will be fully realized.

Our world, which God created good (Genesis 1), is fallen and marred by both individual and systemic sin. Once Christ returns, he will redeem and restore our world: bringing about the New Heaven and New Earth, where pain and suffering will cease forever. As Christians wait for this coming reality, we seek to live like Christ, to see every person as made in God's image, to be Christ's hands and feet to our world, and to partner with God in God's healing and restoration of individuals, communities, and systems. We confess our sins, lament the harm we have caused "by what we have done, and what we have left undone," repent and commit to turn our backs on sin and follow Christ, trusting in God's forgiveness and love.

The Church is the body of Christ (1 Corinthians 12) here on earth: called to witness and carry out God's mission. When we gather together in worship, the Holy Spirit is present with us. When we take part in the sacraments: communion and baptism, the Holy Spirit is certainly present. Taking part in the sacraments is both an individual spiritual experience and an opportunity for us to publicly witness to God's presence and work in our world. "Sacraments are visible, holy signs and seals. They were instituted by God so that by our use of them he might make us understand more clearly the promise of the gospel, and seal that promise" (Heidelberg Catechism 4.066). In a world that can be fragmented and divided, the Sacraments offer a way for the body of Christ to be united as one and take part in a rich tradition that connects us to followers of Christ around the globe and throughout history. As "one holy catholic and apostolic" Church, we are called to repentance, self-sacrificial love, and unity in Christ: to use what God has given us to contribute to God's kingdom.

All human beings are made in God's image and are each a unique reflection of God's image. In a world where division and discord are difficult to ignore, it is by recognizing the ways each person reflects God's image and seeking to understand what they can teach us about God and life in authentic Christian community, that we can learn how to avoid the traps and idolatry rampant in our world and see Christ and one another more clearly. There is so much we can learn from one another, our life experiences, and how God has been at work in our lives, for the sake of God's mission and the redemption and restoration God desires for all God's creation.

Statement of Faith
