Presbytery of Whitewater Valley Stated Assembly Meeting, Saturday, February 5, 2022 MINUTES

Convening the Meeting

Whitewater Valley Presbytery met by video conference for a stated meeting on Saturday, February 5, 2022. The Moderator, Rev. Brian Shivers, called the meeting to order at 10:00 a.m. from the sanctuary of Irvington Presbyterian Church, Indianapolis.

The Moderator opened the meeting with prayer.

The Docket was provided electronically in advance of the meeting. The Moderator called for amendments to the proposed docket. There being no amendments, the docket was approved by consent.

The Moderator instructed presbyters to submit items of new business to the Stated Clerk by 10:30 a.m. for consideration in the afternoon.

The Stated Clerk, Rev. Terry Epling, confirmed that a quorum was present. The attendance report is included at the end of these minutes.

The Rev. Alan Thames, Executive Presbyter, introduced Ruling Elder Jim Rissler (Harvey Browne Presbyterian Church, Louisville), CEO, Presbyterian Investment and Loan Program (PILP); and, the Rev. Kenneth Green (Chicago Presbytery), from the Board of Pensions. Rev. Thames recommended that they be seated as corresponding members. Without objection, they were enrolled.

The minutes of the November 3, 2021 stated meeting were provided in advance. There were no amendments to the minutes. The minutes were approved by consent.

Pyoca Covenant and Proposed Transition Plan - First Reading

Sam Muse, Board of Directors President and Alan Thames, Executive Presbyter The first read of the Revised Covenant and Transition Agreement between Presbytery of Ohio Valley, Presbytery of Whitewater Valley, and Pyoca Camp and Retreat Center was presented for questions and concerns to be referred to the Board of Directors and/or the Coordinating Council Commission, and the Pyoca Board of Directors.

A second read with a vote was tentatively scheduled for the Wednesday, May 4, 2022 Stated Assembly Meeting of the Presbytery.

The Rev. Ken Green spoke to the Assembly electronically using Zoom, to provide current information about the Board of Pensions and to offer his assistance to ministers and churches in navigating the pension and healthcare plans.

ADMINISTRATIVE COMMISSION MINUTES

Commissions of the Presbytery provided the reports of their actions on behalf of the Presbytery in 2021.

1. PRESBYTERY COORDINATING COUNCIL

January 13th, 2021

The Administrative Commissions of Nueva Creacion, First Presbyterian Church, Greenfield, and Ebenezer Presbyterian Church, Lewisville, presented final reports for forwarding to the Presbytery Body. Steve Weissner moved to forward the reports to the Presbytery Body, Ann Hamel seconded, passed.

New Business

Deb Mitchell gave a presentation on the Promise of Tomorrow Phase 2 Grant Application for United Faith Presbyterian Church, Fort Wayne. The motion to approve the grant came from the Connected Communities workgroup, passed. Executive Presbyter Alan Thames talked to the council about needing a Male Ruling Elder to serve on the Committee on Representation and asked for recommendations for nominations from the congregations represented on Coordinating Council.

Mike Whitfield and Brian Shivers presented their planning for the February 6th Presbytery Meeting.

March 24th, 2021

The Administrative Commission of the Amistad Christiana Congregation of Fort Wayne has requested the release of the \$25,000 Promise of Tomorrow Matching Grant. Steve Weissner moved, Rod Smith seconded, passed.

The Council reviewed the Pyoca/WWVP/OVP Covenant for Renewal. Deb Mitchell moved to renew the covenant as presented, Sue Whitaker seconded, passed.

New Business

Council affirmed the nominations presented from committees.

Reba Curtis and Jennifer Linval volunteered to serve on the Administrative Commission for the Circle City Dinner Church.

Approval of \$300 from Synod Rise Up Grant to provide honorarium to Shelly Tochluk, author of Witnessing Whiteness, for speaking to the presbytery book study group. Sue Whitaker moved, Jennifer Heimach seconded, passed.

Mona Dale gave a report on the work of the Community Engagement Work Group. The group plans to send out a survey to pastors and clerks to see what needs churches have.

Rod Smith and Wally Wilson gave a report from the Mission and Partnership Group The Workgroup brought a grant request from the First Presbyterian Church of Bluffton to help with building a labyrinth. Deb Mitchell provided additional information about the project. Passed.

Trish Lisa gave a report from the Personnel Committee. The Committee recommended a sabbatical for Executive Presbyter Alan Thames for 2022. Passed.

April 28, 2021

Nancy Frick requested a motion to elect Eric Herzog to serve as clerk. Rob Brown, moved, Deb Mitchel, seconded. The motion passed.

Alan Thames provided background, a review of prior council actions and the importance of the presbytery offerings not being received at virtual Assembly meetings. Motion by Sue Whitaker to approve designating budgeted funds for the February and May assembly meetings lunch to One Great Hour of Sharing and Pentecost. Ramona Dale seconded; the motion passed.

The council discerned returning to in-person or continuing with a virtual (Zoom) meeting for June 23, 2021. After discussion, consensus is to continue virtual meetings.

Mike Whitfield provided the Assembly Moderator's Report. Mike reported on the excitement around the examination of four candidates for ordination, other topics and the worship service docketed for the May 5 presbytery assembly.

Barry Sumner and Jennifer Linville presented the Hispanic Ministries Lead Team (HMLT) 2021 budget to Council for approval. Barry discussed the background and almost 20-year history of the presbytery HMLT ministry locally and internationally. Nancy Frick opened a period for questions. Alan Thames requested additional information about the funding sent directly to the Presbytery of Riviera Maya. Motion to approve the budget by Steve Weissner, Ryan Crismore seconded, motion approved.

Jenni Heimach reported on behalf of Justice Advocates. The team is having discussions about ways Justice Advocates can communicate mission and resource congregations and will report back to Council.

Sue Whitaker reported for the Finance Committee. The finance team meets next on June 17 to review May 2021 financials and the first read of the 2022 presbytery budgets.

Trish Lisa reported for the Personnel Committee.

Alan Thames reported a request from the Presbytery Board of Directors (BOD) to form a task force to work on the details of Pyoca's move to an independent corporation and 501(c)(3) organization. The task force will include two members of the BOD, two members from Council and will be staffed by Alan Thames and Eric Herzog. Council members Max Muska and Trish Lisa agreed to serve reporting back to Council.

[Community Engagement and Mission & Partnership Work Groups exited the Council plenary meeting to participate in 30-minute virtual breakout sessions.] [Council reconvenes]

Ramona Dale reported for Community Engagement. The work group discussed the results of the recent surveys of pastors and clerks. The team was pleased with the feedback and a subgroup of 3 members will be assembling the data collected and reporting results back to Council.

Wally Wilson reported for Mission & Partnership. The work group made direct contact with several churches and experienced mixed results. Feedback from the churches contacted included a desire to see actions from the calls, surveys, etc. generated by the presbytery. Regarding participation, there was a consensus of exhaustion at the churches and that surveys, calls, etc. was just one more thing to accomplish. A discussion ensued about considerations relating to timing and the liturgical calendar when Council implements these types of actions.

The Council received an updated report of grant awards from the Council Emergency Technology Grant Fund. The fund was established during 2020 to assist churches developing an online worship presence or otherwise improving technology use. The fund has disbursed \$22k and has a \$13k balance available for this ongoing work.

June 23, 2021

Mike Whitfield reported the August Assembly meeting will be offered virtually (Zoom) with an optional in-person attendance at Irvington PC.

Max Muska updated Council on the progress and reasoning behind the Pyoca transition to a separate organization. Alan Thames discussed next steps.

Jennifer Linville reported that the Dominican Republic VBS is on hold due to the pandemic. HMLT celebrates the \$4,500 gifted for Dorcas Baskets and \$22,500 disbursed to Mexico to support leadership events, VBS and youth camp.

Nancy Frick presented updates from the Design Team for Dismantling Structural Racism including materials for Juneteenth and a request for an initial review of a statement for Dismantling Structural Racism. Feedback and suggested revisions will be considered by the Design Team.

Sue Whitaker presented the May 2021 financial reports and reviewed the 2022 (1st read) Mission Operations and Mission Focus Units budgets recommended for approval by the Finance Committee. Operating budget includes a \$0.87 presbytery per capita increase to help maintain a balanced budget for the period and provide flexibility for future budget periods. Council did not take action to approve the 1st read budgets.

Council Executive Committee action: Moved, seconded and approved the appointment of a Committee of Administrative Review (as specified in G-3.0108) at the request of the Session of First Presbyterian Church, Fort Wayne to inquire into questions concerning the administration and accountability of Smock Senior Ministries and its related entities and to make recommendations to cure any deficiencies or errors with the appointment of the Committee on Administrative Review to include no more than three (3) persons and no more than five (5) persons appointed by the Executive Presbyter, who shall serve as the primary staff person to the Committee.

July 28, 2021

Report from Mission & Partnership Work Group - Wally Wilson

Motion by Wally Wilson to grant an additional \$5,000 to FPC Bluffton for a church labyrinth construction (\$4,000 granted previously) from New Ministry Initiatives \$1,500, Mission in Congregations \$1,500, and Peacemaking \$2,000. Second Deb Mitchell. Approved.

Report from Community Engagement Work Group - Mona Dale

Mona provided an update on progress by the work group resulting from survey responses received from pastors and clerks. Working with presbytery staff on closed social media groups specific to communications for these groups. Coordination with the finance committee for in person training on administration and finance for churches is in development.

Report from Personnel Committee - Trish Lisa

Trish reports staff reviews have been completed. Monthly in-person staff meetings are being coordinated with Alan. Motion by the Personnel Committee to allow presbytery staff (in office) schedules flexibility. Approved.

Motion by the Finance Committee recommending the 2022 proposed budgets (reviewed during the prior Council meeting) be included for a first read by the Presbytery Assembly, August meeting. Approved.

Deb Mitchell presented an update on the actions of the St. Andrew Administrative Commission.

Alan Thames provided an update on the Committee for Administrative Review. Committee composition includes Jan DeVries (Honorably Retired Minster of Word and Sacrament), Martha Nommay (Second Presbyterian Church, Indianapolis) and John Purcell (Northminster Presbyterian Church, Indianapolis) Nancy Frick recommended the formation of a task force to address concerns relating to balancing the presentation of confidential issues while maintain transparency to the Coordinating Council.

2. COMMISSION ON MINISTRY (COM) REPORTED ACTIONS

January 27, 2021

Pastoral Support: Mike Whitfield

Mike reported on the surveys returned from Pastors and the Prayer Plan moving forward. Mike reported that, in this time of Covid, Pastors reported feeling angst, experiencing personal and community grief. Need for proper mourning, and feeling a lack of connection. There is stress of doing everything, as well as doing everything differently. Added issues of social/political/justice create more stress.

Asked that Presbytery Assembly address issues of Pastor's Self-care, how to best lead in this time, and church finances. Mike talked about the upcoming service of Lament and Hope at the Presbytery Assembly on February 6th. Sharing hope for the future.

Special Parish Ministries: Eric Gale

Eric reported that they are getting organized with knowing CREs, Designated Pastors, and finding new ways to be of support to them.

Liaison: Jon Richwine

Jon reported that the MIF for the Korean Presbyterian Church of Indianapolis was approved by the team and made the motion that it be approved by COM. Passed!

Validated Ministries: Martha McDonald

The team added names of Validated Ministers to the list of those already known, will get contact information for these ministers.

March 24, 2021

Kelly Spencer: Kelly is a Lakefellow at Second Presbyterian and is seeking ordination in the PC(USA). Rev. Chris Henry was with Kelly for the interview. After her interview, we dismissed Kelly and Chris to the virtual "room" and held a lengthy discussion on BOO requirements for ordination. Moved to use G. 2.0610 at the May 5th Presbytery Assembly to Recommend Kelly Spencer for ordination and approve exemption of yearlong candidacy with ³/₄ vote of the Assembly. MSP Recommend that following that vote by the Assembly, that we move ahead with Kelly's ordination examination. MSP.

Kelly and Chris returned to the meeting, we explained the lengthy discussion and decision. Jon Richwine offered the prayer for Kelly as we move forward.

The Rev. Madison Van Veelen: Madison was accompanied by The Rev. Chris Henry and the APNC from Second Presbyterian, Indianapolis: Steve Johnson, Ron Snow, Chas Bolton, and Ellen Gullet. Madison was dismissed to the virtual "room" and a conversation was held with the APNC. Ron Snow gave an overview of the APNC. COM required that the position be open for three (3) months, and Second extended it to four (4) months. The search for an Associate was unlimited. They received 372 PIFs, narrowed it to 28 candidates and 10 referrals; Offered interviews to 11 and 4 accepted. From those 4 they narrowed their search down to 2 Candidates, including Madison. The other candidate withdrew their name, so Madison was chosen as their candidate. The APNC fulfilled their commitment to COM to seek an Associate beyond Second Presbyterian. December 2021 Financial Reports

- Mission Operations Ministry Fund
 - Ended the calendar year with a surplus of \$21,803. Total fund resources slightly exceeded budget estimates, below prior year results (\$9,101).
 - Per capita gifts from our churches ended the year at 98% of the total apportionment, consistent with budget estimates, below the prior year results by 1%.
 - Total operating expenses (before transfers) ended the year \$20,302 below budget estimates, (\$18,502) above the prior year. Leadership, Office Services and Reimbursements budget groups ended the year at or below budget estimates.
 - The operating ministry fund ended the year with a balance of \$82,074 (target balance \$25k). The Finance Committee budget for 2021 estimated a \$83,183 ending fund balance.
- Mission Focus Units Fund
 - Ended the calendar year with a surplus of \$25,490. Total resources for shared mission exceeded budget by 5% (\$7,124), below the prior year (\$5,111). Mission partners and church grant support funded in full per budget. Council ministry team expenses and allocations below budget \$18,365.
 - The shared mission fund ended the year with a balance of \$54,174 (target balance \$50k). The Finance Committee budget for 2021 estimated a \$48,160 ending fund balance.
- Presbytery **unrestricted** net assets total \$483,288 on December 31, 2021.

STATED CLERK REPORT

1. Death of Minister Member Richard C. Smith

The Rev. Richard C. Smith died on April 23, 2022, at his home in Kokomo, Indiana, at the age of 95. Rev. Smith was ordained December 29, 1958. He served as a missionary in Omdurman, Sudan, and was pastor of United Presbyterian Church in Wurtemburg, Pennsylvania from 1958-1964, Faith Presbyterian Church in St. Clair Shores, Michigan from 1964-1982, and First Presbyterian Church in Marion, Indiana from 1982-1991. He was honorably retired by Whitewater Valley Presbytery on December 1, 1991.

A Covenant Among The Presbytery of Ohio Valley, The Presbytery of Whitewater Valley, and the Pyoca Camp and Retreat Center (proposed 2022 revision)

I. Parties

This revised covenant is entered into between the Presbyteries of Ohio Valley and Whitewater Valley and Pyoca Camp and Retreat Center, Inc. (PCRC), an Indiana not-for-profit public benefit corporation. The original covenant was agreed to by all parties in 2019.

II. Covenant

The Presbyteries of Ohio Valley and Whitewater Valley and the PCRC covenant together to affirm our support for Camp Pyoca, and our present and historic partnership and mutuality of purpose in providing for Camp Pyoca and to outline the promises of all parties to each other as the PCRC establishes itself as a non-profit camp and retreat center to carry on the mission and purpose of Camp Pyoca. Recognizing that the future may bring significant changes for the PCRC and the partner Presbyteries, it is anticipated that this Covenant will be revised as circumstances evolve, and agree to review and renew this Covenant at least every three years, or at the request of any of the parties as circumstances require.

III. The Promises of the Presbyteries of Ohio Valley and Whitewater Valley to the PCRC

- A. The Presbyteries provide PCRC an affiliation with the Presbyterian Church (USA) and recognize PCRC as an institution related to both Presbyteries through this Covenant. The Presbyteries recognize PCRC as an institution with ties to the Presbyterian Church (USA) where programs with multiple denominations and/or interfaith endeavors may take place.
- B. Recognizing that PCRC will be an independent entity, the Presbyteries will encourage their pastors and congregations to consider the PCRC for summer camping programs, retreats, and/or other conferences hosted by the PCRC. They will publicize the PCRC camps, retreats, and other programs on their web sites and in emails, newsletters, etc., and will provide links on their web sites to the the PCRC home page.
- C. The Presbyteries will collaborate with the PCRC in planning and sponsoring events each year designed to meet the needs of the Church: these may include, but are not limited to Presbytery assemblies, youth conferences, or pastor retreats.
- D. The staff and leaders of both Presbyteries will strive to remain informed about the programs and policies of the PCRC, and will support and interpret its mission.
- E. Each Presbytery will provide access to its Council, and will offer the PCRC the opportunity to report at its regular assemblies.

- F. Each Presbytery will name two nominees to the the PCRC Board of Directors each year through its normal election process. Should the Board of Directors not elect a nominee from a Presbytery, it will request that the Presbytery nominate an alternative.
- G. The Presbyteries will encourage support of the PCRC through inclusion of financial support in their annual budgets, and will encourage congregations to participate in the financial support and fundraising objectives of the PCRC, in consultation with and in collaboration between the PCRC and the Presbytery Councils.

IV. An Additional Promise of the Presbytery of Whitewater Valley to the PCRC

The Presbytery of Whitewater Valley, working through the Board of Directors and the Coordinating Council, intends at the appropriate time to transfer the current Camp Pyoca real property, fixtures, equipment, and tangible assets to the new independent PCRC for reasonable consideration. Terms of this transfer to be addressed in a separate Transition Agreement between the Presbytery of Whitewater Valley and the PCRC.

V. The Promises of the PCRC to the Presbyteries of Ohio Valley and Whitewater Valley

- A. The PCRC covenants to offer staff leadership and physical facilities for appropriate training events, programs, seminars, and related activities, including events specifically designed to meet the needs of the Presbyteries, their member congregations, and their other organizations and institutions.
- B. The PCRC will provide complimentary weekday lodging for renewal and study leave to pastoral leaders and youth staff of congregations from both Presbyteries, and will communicate this amenity to the Presbyteries each year.
- C. The PCRC will offer a lodging discount to congregations from both Presbyteries for youth, adult, and family retreats, and will communicate this discount to the Presbyteries each year.
- D. The PCRC Board of Directors will operate according to its bylaws. The PCRC will provide both Presbyteries an annual financial report with periodic updates as necessary at the request of the leadership of either Presbytery.
- E. The PCRC will provide programming and leadership to uphold the historic and present focus of the Reformed tradition.
- F. The PCRC will cooperate and collaborate with both Presbyteries, seeking ways to support them, their member congregations, and their other organizations and institutions.

VI. Additional Promises of the PCRC to the Presbytery of Whitewater Valley

A. The PCRC will maintain the real property, fixtures, equipment, and tangible assets of Camp Pyoca and of the PCRC in good working order and repair, and will make improvements as finances allow and needs require.

- B. During the transition of Camp Pyoca to an independent camp and retreat center and until a final transfer of the property is executed, the PCRC shall not incur any material indebtedness without the advance approval of the Presbytery of Whitewater Valley. In the spirit of the historic partnership of Camp Pyoca and the Presbytery of Whitewater Valley, consultation between the PCRC and the Presbytery of Whitewater Valley concerning encumbrances on the land or buildings shall continue once the transition is complete (in keeping with the provision in Section VI. C. below).
- C. The The PCRC Board of Directors will not sell any land or buildings transferred to it from the Presbytery of Whitewater Valley without prior consultation with and approval from the Presbytery's Board of Directors. If at any time in the future the PCRC is formally dissolved, declares bankruptcy, has a receiver appointed, or finds it is unable to continue as an independent entity, its real and personal assets remaining after provision for payment of valid debts and liabilities shall be distributed to the Presbytery or its successor.

THIS TRANSITION AGREEMENT ("Agreement") is made to be effective on 2-22-2022, by and between the PRESBYTERY OF WHITEWATER VALLEY, INC. an Indiana nonprofit corporation (the "Presbytery") and PYOCA CAMP AND RETREAT CENTER, INC., an Indiana nonprofit corporation ("PCRC"). The Presbytery and PCRC, as the "Parties" to this Agreement now agree as follows:

- 1. **Mission and Support.** The Presbytery of Whitewater Valley and the Presbytery of Ohio Valley (POHV) have worked together to support Camp Pyoca for many years. Both presbyteries have a strong interest in perpetuating the mission of Camp Pyoca, and both have delegates to the Camp Pyoca Advisory Council. The Presbytery of Whitewater Valley is the owner of the real estate on which Camp Pyoca is located. The Presbytery, POHV, and the Camp Pyoca Advisory Council have explored establishing an independent not for profit camp and retreat center and eventual transfer of the Camp Pyoca property to this new independent entity. PCRC has been formed with the intent it will be this entity. The Presbytery and POHV entered into a "Covenant and Agreement with the Presbytery of Whitewater Valley, the Presbytery of Ohio Valley, and Pyoca Camp and Retreat Center," approved during the Spring of 2019. The Covenant is incorporated in and made a part of this Agreement and is attached as Exhibit A to this Agreement.
- 2. Transition and Financial Support. This Agreement is intended to assist the Parties in transitioning the control and ownership of Camp Pyoca to the PCRC, while PCRC continues to take the steps necessary before receiving the camp property and establishing itself as a tax-exempt organization and a financially stable, independent organization. The Parties agree to work in good faith through this period of transition and recognize that amendments to the Pyoca Covenant and this Agreement may be considered as the need arises. The Presbytery agrees to provide financial support for Camp Pyoca as part of its annual budget process and agrees to provide the approved budgeted amount for Camp Pyoca in the form of quarterly payments to the PCRC (the "Presbytery Support Funds"). Future Presbytery Support Funds may be provided as approved by the Presbytery. The 2022 Presbytery Support Funds shall be used by PCRC only for the support of Pyoca's operations, mission, and ministry. Distributions to PCRC of the funds generated through its ministry (currently held in a Presbytery-owned bank account), as approved by the Presbytery's Board of Directors will be made as follows: (i) \$100,000 by about May 15, 2022; and (ii) any amount remaining in the designated account for support of Pyoca's operations within thirty (30) days of the satisfaction of the following three conditions: (A) IRS approval of tax-exempt 501(C)(3) status for PCRC; (B) adoption of a Revised Covenant Agreement among the Presbytery of Ohio Valley, the Presbytery of Whitewater Valley, and PCRC as approved by each Presbytery's general assembly and PCRC's Board of Directors; and (C) payment in full of all "Due-To" and other liabilities owed to the Presbytery of Whitewater Valley by PCRC.
- 3. **Real Property.** As a middle governing body of the Presbyterian Church (U.S.A.) and the owner of the real and personal property of Camp Pyoca, the Presbytery is subject to the provisions of G-4.02 governing "Church Property," including G-4.0203 requiring all church property to be held in trust for the use and benefit of the Presbyterian Church (U.S.A.). It is intended for the Camp Pyoca property to be contributed to PCRC as soon as administratively feasible by both the Presbytery and

PCRC. The satisfaction of IRS approval of tax-exempt 501(C)(3) for PCRC and approval by all signatory parties to be revised Covenant Agreement is required for any real property to be transferred to PCRC. If formal IRS approval of tax-exempt 501(C)(3) status is not obtained by May 15th, 2022, the Presbytery and PCRC will enter into a "Lease Agreement" (the "Lease") for a mutually agreed upon time period. It is intended PCRC shall begin operations of the ministry upon the start date of the lease agreement. The Lease may be renewed as described in the Lease.

- 4. **PCRC Requirements.** As condition to receiving financial support from the Presbytery, PCRC shall do the following:
 - a. PCRC shall take all necessary and reasonable steps to obtain and maintain tax exempt status from the Internal Revenue Service as a not-for-profit public benefit corporation.
 - b. PRCC shall take all necessary and reasonable steps to adhere to the Covenant Agreement, and the Lease Agreement, including any amendments thereto.
 - c. PCRC shall obtain and maintain general liability, worker's compensation, automobile, and Directors and Officers insurance. PCRC shall provide evidence of coverage as well as amounts of coverage to the Presbytery of Whitewater Valley upon coverage being bound. Presently, the Insurance Board provides coverage for the Presbytery and has agreed to extend coverage to PCRC for general liability and Directors and Officers policies. The Presbytery will be named as an additional insured on all PCRC policies but may also maintain its own insurance policies. PCRC will be fully responsible for the cost of all of its insurance policies.
 - d. PCRC shall adopt and maintain a Sexual Misconduct Policy, a Child Protection Policy, a Personnel Policy, and an operating manual or policy, each of which shall be subject to the review of the Presbytery through its Coordinating Council prior to entering into the Lease Agreement. PCRC shall provide the Presbytery with copies of these policies as soon as administratively possible, but prior to execution of this document and the Lease Agreement.
 - e. All PCRC employees and all volunteers who work with children or youth under the age of 18 shall be subject to a criminal records background check, and all PCRC personnel, including board members, advisory board members, staff and volunteers shall participate in annual training related to boundary issues, sexual misconduct, child abuse, child sexual abuse, and related matters. This training shall be provided by one or more presenters before the commencement of any camping activities involving children under age 18 and shall include training materials and content subject to the review of the Presbytery through its Coordinating Council prior to entering into the Lease Agreement. PCRC shall provide the Presbytery with a description of the provided training and any relevant materials utilized as soon as administratively possible, but prior to execution of this document.
 - f. By May 15, 2022, PCRC shall become the employer of Pyoca staff, and shall take all necessary and reasonable steps to assume the administration of payroll and benefits for Camp Pyoca staff, it being understood that those Camp Pyoca personnel who participate in the Board of Pensions benefits programs of the Presbyterian Church (U.S.A.) will be eligible to continue to participate in the Presbyterian Church (U.S.A.) Board of Pensions benefits programs. PCRC shall be fully responsible for the administration and payment of payroll and benefits for all of its paid employees.

- g. PCRC shall maintain bank and other financial accounts in its own name and shall be fully responsible for the administration of such accounts. PCRC shall obtain an independent financial review or audit by an independent accounting professional on an annual basis and provide the independent professional's report to the Presbytery through its Board of Directors within thirty (30) days of the completion of the review/audit.
- h. PCRC shall keep the Presbytery through its Coordinating Council fully advised of its public announcements and fund raising activities, and it shall provide copies to the Presbytery of any publicity or fund raising materials (solicitation letters, brochures, presentations, website or social media postings, etc.) that mention or refer to the Presbytery in advance of any distribution or disclosure to the public to assure consistency with the applicable agreements and covenants and clear messaging about the transition.
- 5. **Presbytery Commitments.** In addition to the financial support described above, the Presbytery endeavors to do the following:
 - a. When requested, reasonable assist PCRC to establish an endowment and restricted funds, develop a capital funds campaign, and other financial and long-term planning in order to support PCRC as an independent, financially viable entity and provide for Camp infrastructure, maintenance, and construction projects, significant renovations to Camp buildings, and camping scholarships.
 - b. Work with PCRC to plan for year-round staff, including financial planning for staffing needs, identifying the best people/skills needed for PCRC and Pyoca, assisting with PCRC Board development (including diversity issues, the need for specific skillsets, and board governance training) as requested. The Presbytery is willing and able to help with board recruitment, training, and development.
 - c. Assist PCRC to adopt the policies and other steps described in paragraphs 4d and 4e above.
 - d. Work with PCRC toward transition issues and processes with the Board of Pensions of the Presbyterian Church (U.S.A.) as necessary.
 - e. The general assembly of the Presbytery will review this Transition Agreement and proposed amended Covenant Agreement during its meeting scheduled for February 5, 2022.

6. Other Terms.

- a. The Parties agree that this Agreement and the transition shall be subject to the Book of Order of the Presbyterian Church (U.S.A.), the Presbytery's Standing Rules and policies and procedures, and Exhibits A and B to this Agreement. In addition, this Agreement shall be governed by the laws of Indiana.
- b. The Parties agree to do those things and execute documents and instructions as reasonably required to carry out the intent and terms of this Agreement.

c. The Presbytery of Whitewater Valley's Board of Directors will work with PCRC's Board of Directors to determine an appropriate long-term plan to address potential transition or management of the endowed funds held within the Presbytery's "New Covenant Funds."

Each party, intending to be legally bound, and the signatories below attesting they are duly empowered and authorized to execute this Agreement on behalf of the Party for which they sign, signs this Agreement effective as to the date first written above.

Enclosures: Letter 947 The Coordinating Council Commission of Whitewater Valley Presbytery, composed of equal numbers of Ruling and Teaching Elders representing congregations throughout our presbytery, has been discerning the changing nature of presbytery assembly meetings. As we all know, the pandemic made it necessary for the presbytery to shift to largely virtual meetings during the past 2 years. Our first virtual presbytery assembly took place two years ago in May 2020.

Although the pandemic no longer forces us to follow the strict protocols we once had in place, Council is also aware of the carbon footprint of presbytery meetings when long distance travel is involved in attending assembly meeting of the presbytery. Therefore, the Coordinating Council has approved a new model for presbytery assembly meetings as we move into the future:

- Two (2) meetings each year will be virtual (February and August) and two (2) meetings each year (May and November) will be hybrid with in-person and virtual opportunities to participate
 - 1. Weather in February is often unpredictable making a virtual option viable for more participants.
 - 2. Participation at the August assembly is typically the lowest of the four annual assembly meetings and is often during vacation time for many.
 - 3. A hybrid model for two assembly meetings preserves the opportunity many desire for in-person connection while reducing the carbon footprint and the expense of travel.
 - 4. For those unable to attend meetings in-person at all due to health concerns, a virtual option will always be available.
 - 5. Presbytery assembly meetings involving special occasions (significant church anniversary, noteworthy speakers/presenters, etc.) could be in-person events as decided by the Coordinating Council in consultation with presbytery leadership.
- For hybrid meetings, presbytery assembly meetings will be held at one main site (the Indiana Interchurch Center where the presbytery office is located) with satellite sites selected for geographical diversity offered throughout the Presbytery
 - 1. Fellowship opportunities are possible in smaller settings with less travel involved.
 - 2. Meals could be hosted by individual satellite sites and reimbursed by the Presbytery.
 - 3. Presbytery Technology Coordinator Craig Shaw will develop checklist for technological requirements for satellite sites and would offer coaching for effective/efficient set-up and monitoring.
 - 4. Quality webcams and other equipment for each satellite site would be purchased by the Presbytery and housed/stored at satellite sites; additional equipment for livestreaming from the main site would also be purchased by the Presbytery and housed at offices.
 - 5. Presbytery Administrative Assistant Dawn West would adapt registration to provide information regarding sites from which participants could participate; she also would coordinate responsibilities (i.e. registered participants, meals, etc.) involved with hosting.
- Floor Discussions and Voting will reflect a strong commitment to give equal voice to all participants regardless of mode of participation
 - 1. Presbytery staff and/or elected Presbytery leaders will monitor in-person space and virtual space
 - 2. Virtual and in-person participants will have alternating opportunities to speak
 - 3. Documents for all presentations would need to be available to the Presbytery staff ahead of meetings for ease of sharing in virtual and in-person settings

The Community & Engagement workgroup of the Coordinating Council sent a survey asking about needs in the presbytery. A recurring theme was the desire for a private, online space for pastors to connect with other pastors and clerks to connect with other clerks.

Charge to the Administrative Commission

For the Dissolution of Hope United Presbyterian Church, Plainfield, Indiana

By the Presbytery of Whitewater Valley

In response to a congregational vote by Hope United Presbyterian Church on Sunday, April 24, 2022, the Commission on Ministry recommends the following:

For the purpose of dissolving the congregation of Hope United Presbyterian Church of Plainfield, Indiana the Presbytery of Whitewater Valley appoints an Administrative Commission to act on the Presbytery's behalf, effective May 4, 2021 with the following powers and functions for the purpose of dissolving a congregation in a timeframe required to complete the work as specified below:

- To meet and consult with the Session to facilitate the work of the Administrative Commission;
- To arrange for the pastoral care of the members of the congregation;
- To publicize the dissolution of the congregation;
- To ascertain the financial status and outstanding financial obligations of the congregation, to secure the Session records and, as determined by the Administrative Commission, secure the legal rights to all property (real or personal) held by or for the benefit of the congregation;
- To dispose of the moveable personal property of the congregation, secure the building and property, attend to matters of insurance, dispose of the building and grounds, or convey the building and grounds to The Presbytery of Whitewater Valley, Inc.;
- To recommend to the Presbytery the use of the assets of the congregation;
- To assure that a Service of Witness is conducted and to participate in that service and to determine the effective date of dissolution;
- To secure the assistance of other individuals as appropriate to assist with its work, and generally to do such things and take such actions in the name of and on behalf of the Presbytery of Whitewater Valley, as shall be reasonably necessary to accomplish the general purpose of this resolution; all other business and actions related to the dissolution of the congregation;
- To provide a written report of actions of the Administrative Commission at the conclusion of its work which will be presented to the Presbytery Assembly with dismissal of the Administrative Commission to follow.

Statement of Faith
