CONVENING THE MEETING

Call to Order

Whitewater Valley Presbytery met by video conference for a stated meeting on Wednesday, August 5, 2023. The Moderator, Ruling Elder Muriel Treadwell, called the meeting to order at 10:00 a.m. from the Indiana Interchurch Center, Indianapolis.

Opening Prayer

The Moderator opened the meeting with prayer.

Adoption of the Docket

The Docket was provided electronically in advance of the meeting. The Moderator called for amendments to the proposed docket. There being no amendments, the docket was approved by consent.

New Business

The Moderator instructed presbyters to submit items of new business to the Stated Clerk by 10:30 a.m. for consideration later in the gathering.

Quorum

The Stated Clerk, Rev. Terry Epling, confirmed that a quorum was present. The attendance report is included at the end of these minutes.

Welcome

The Rev. Alan Thames, Executive Presbyter, welcomed everyone to the gathering. Rev. Thames introduced Rev. Barry Sumner who made an announcement regarding the Hispanic Ministries Lead Team and its planned trip to the Dominican Republic in spring 2024. Rev. Sumner invited congregational participation in the Dorcus Basket program to provide suitcases filled with Vacation Bible School materials to mission communities.

Minutes and Financial Reports

The minutes of the May 3, 2023 stated assembly meeting were provided in advance. There were no amendments to the minutes. The minutes were approved by consent.

All financial reports of the Presbytery for January 1, 2023-May 31, 2023 were provided electronically in advance for information.

Transitions Within the Presbytery

The Rev. Gretchen Schneider, Moderator of the Commission on Ministry, reported on pastoral transitions in the presbytery.

Presbyterian Mission Agency

Rev. Thames introduced Lauren Rogers, Ministry Engagement Advisor with the Presbyterian Mission Agency. Ms. Rogers described her role as providing help and support to congregations as a cheerleader and connector to assist with mission goals. She spoke to mission opportunities through the Matthew 25 Initiative. She thanked congregations participating in the four national offerings. She invited the Presbytery to celebrate that 18 Young Adult Volunteers were commissioned in August to mission in the PC(USA).

ACTION ITEMS

Ordination Examination

Rev. Gretchen Schneider introduced Taekjin (David) Kim, a Certified Candidate under care of New Hope Presbytery. Mr. Kim was presented with a call as Lake Fellow Resident Pastor of Second Presbyterian Church, Indianapolis. He was examined for membership and goodness of fit by the Commission on Ministry. His statement of faith was distributed electronically with the call papers.

The Moderator opened the floor for examination for ordination and invited Rev. Schneider to ask the first question. There were six questions from the floor.

A motion was made, seconded, and approved to arrest the examination. Rev. Schneider escorted Mr. Kim from the room.

The Moderator put the question, shall the examination be sustained and the candidate approved for ordination, and invited discussion. There was no discussion. The motion was approved unanimously by electronic ballot.

Mr. Kim returned to the room and was welcomed with applause and congratulations. Having been approved for ordination he will be ordained by New Hope Presbytery in his home congregation.

Minimum Terms of Call

The Commission on Ministry recommended adoption of Minimum Terms of Call for 2024. The proposed terms were distributed electronically prior to the meeting. There was no discussion of the proposal. The vote was taken electronically and approved without objection. The 2024 Terms of Call as adopted are attached to these minutes following the attendance roll.

2024 Mission Operations Budget - First Reading

Ruling Elder Greg Maiers from the Finance Committee of the Coordinating Council Commission presented the proposed 2024 Mission Operations Budget for a first reading. The proposal had been distributed electronically in advance of the meeting. Mr. Maiers invited questions and responded. The 2024 Mission Operations Budget will come to the November Assembly for adoption.

Other Business

On the recommendation of the Moderator, without dissent, the report of the Administrative Commission to Emmanuel Presbyterian Church was postponed to the November stated assembly.

Special Called Assembly Announced

The Moderator announced that at the request of the Transitional Lead Presbyter Search Committee the Coordinating Council Commission had authorized her to call a special called meeting on Saturday, September 20, 2023, in order to present the nomination of the Search Committee. The following information was used to formulate the Minimum Compensation:

- The full-time median salary of PC USA pastors rose 3.5% for the subject reporting period. The Pastor Support Subcommittee of the Commission on Ministry uses 80% of the published median (\$67,100) to set the base compensation minimum for full-time pastors in the presbytery.
- The Board of Pensions of the Presbyterian Church (USA) annually tabulates the median and average effective salary information reported to it for minister members of the Benefits Plan who are serving U.S. congregations. The median salary is generally considered more representative than the average salary, since it is less influenced by very high or very low salaries.
- The Pastor Support Subcommittee applies an increase or decrease to the full-time median salary minimum using data provided by the Bureau of Labor Statistics (www.bls..gov) Consumer Price Index (CPI) Midwest Urban Report. A 3-year rolling average is applied to the CPD reporting period to offset unusual spikes in the reported average. The data reflects an increase of 5.6% for the subject period.

Terms of Call Transitional Lead Presbyter Whitewater Valley Presbytery

The Presbytery of Whitewater Valley of the Presbyterian Church (U.S.A.), being well satisfied with your qualifications for ministry and confident that we have been led to you by the Holy Spirit as one whose service will be profitable to the spiritual interests of our presbytery and fruitful for the Kingdom of our Lord, earnestly and solemnly calls you, Erin McGee, to undertake the office of Transitional Lead Presbyter of this presbytery, beginning January 1, 2024, promising you in the discharge of your duty all proper support, encouragement, and allegiance in the Lord.

That you may be free to devote yourself full time to this ministry among us, we promise and obligate ourselves to pay the following:

and we will pay regularly in advance to the board responsible for benefits a sum equal to that requisite percent of your salary which may be fixed by the General Assembly of the Presbyterian Church (U.S.A.) for participation in the Benefits Plan of the Presbyterian Church (U.S.A.), including both pension and medical coverage, or any successor plan approved by the General Assembly, during the time of your being and continuing in the position set forth in this call to this presbytery. We further promise and obligate ourselves to review with your annually the adequacy of this compensation.

This agreement is for a term of three (3) years, after which it will either terminate or be replaced by a new Terms of Call agreement upon the recommendation of the Personnel Committee of Whitewater Valley Presbytery, and the approval of the Assembly of the Whitewater Valley Presbytery.

While we expect a beautiful and fruitful relationship between the Transitional Lead Pastor and Whitewater Valley Presbytery, this agreement may be terminated by either party with 90 days written notice to the other party. If terminated by the Transitional Lead Presbyter, they shall forfeit all claim to compensation beyond the effective date of termination, except for accrued vacation and study leave allowance. If terminated by the presbytery, the effective salary and Board of Pensions membership shall continue for a period of 90 days after the termination date, or until the Transitional Lead Presbyter secures full-time employment, whichever occurs first.

October 17, 2023 - Council Finance Committee Report

September 2023 Financial Reports

- Mission Operations Ministry Fund
 - Ended the September 2023 period with a fund surplus of \$ 50,121. The surplus balance will be reduced as quarterly fund disbursements are likely to exceed anticipated revenue for the October-December 2023 reporting periods. Additionally, unbudgeted disbursements relating to the hiring of an Executive Presbyter are anticipated (\$15k estimated)
- Mission Focus Units Fund
 - Ended the September 2023 period with a deficit of (\$33,872). Total resources for shared mission below budget (\$42,241). While we anticipate a 4%-6% shortfall in shared mission gifts as compared to the 2023 budget, the current 27% shortfall appears to be partially timing related, as shared mission giving is skewed toward yearend and one of the top five donors has yet to remit their mission pledge for 2023 (\$24k).
 - Presbytery shared mission gift receipts ended the September period 5% below the percentage of shared mission receipts for this period last year.
- Presbytery **unrestricted** net assets total \$573,943 on September 30, 2023.

2024 Presbytery Budgets (2nd Read)

- Mission Operations Budget
 - Net decrease from the first read of the budget (\$1,036). Budget projects a deficit of (\$45,894). [Final EP Terms of Call, computer/software, mileage/prof expense. BOP final healthcare premiums for menu options employees. Insurance adjustment based on other market premium adjustments being realized. Stated Clerk remote office (mileage). Food/meals costs increase. Retired Pastor (participation)]
- Mission Focus Units Budget
 - Shared mission funding is projected to decrease 6.2% (\$9,712) in 2024 as compared to the 2023 forecast. COM (\$1,500) estimated reduction in LeaderWise invoicing, CPM (\$2,000) line-item reduction based on prior period actuals and current number of candidates under care. Budget reflects a deficit of (\$9,139).

SG named her past and upcoming course and is starting supervised ministry in fall at Trinity Pres. SG learns through working through the discomfort of new situations; doing pulpit supply; learning from Martin (spouse) and other ministers in the area; She has applied for support from Beamer Scholarship at First FW, applied for renewal of a PCUSA scholarship, and is applying through CTS but has not yet heard results. Maureen gave her the information for the Joan Malick Scholarship at Second. CPM approved her as an Inquirer today and Alice McDowell is assigned as liaison.

9/11/2023

Interview with Ian Clark (via zoom): Ian introduced himself and presented his call story, being very much rooted in his church since birth. His ministry experience is mainly in teaching preschool (his college major was elementary education) and he has a strong interest in the arts, especially music. Ian said "I have listened to my internal direction and placed myself in a place to respond." He started seminary in Austin just days ago, and responded to questions about his studies (he loves seminary and his professors) and his self care practices. He also spoke of how he is organizing his schedule and how music is a vital part of his self care and every day centeredness. 2022 Finance Review (auditor section) – Motion to approve engagement with Comer Nowling for Financial Review. Phil moved and Girtha seconded. MOTION passed.

4/27/23

Church PILP Designations/Investments – All churches with investor funds loans are earning a 1% interest rebate. Spoke with PILP about diverting about \$500,000 to higher yield investments. PILP is offering WWVP 3.25% on a 15-month investment. Discussion ensued to keep funding with PILP or move to commercial account (i.e., Vanguard). Phil motion to move \$200k to Vanguard Money Market, and the balance not needed to fund church interest rebates to the PILP 15-month offering. Second Shawn. Approved. New Business Eric reviewed Zionsville PC request for permission to encumber the church property with a 3 million loan as part of a 13-million-dollar expansion / renovations. All documents requested by the BOD with an encumbrance request and commercial loan have been received and are in order. Pledges and cash on hand cover roughly one-half of the total project. Additional pledges may be received. Motion to approve by Phil. Second Shawn. Approved.

Alan provided an update on the PYOCA property transfer –working on this and DNR to approve an easement they must have to move forward with the property transfer. Judy Woods (Presbytery's counsel) and David Frangos (PYOCA counsel) are working on this and waiting on DNR response. 2 Whitewater Valley Presbytery Board of Directors Minutes Sam opened a discussion on Witherspoon PC – Michigan Road. PILP has conditionally approved renovation loan of \$500k. With cash on hand/pledges it will allow the church to move forward with renovations. Witherspoon PC requests that the presbytery transfer Kessler Blvd property to Witherspoon and simultaneously Witherspoon transfers Michigan Road to the presbytery. Motion to approve property(s) deed transfer by Phil with a Transition Agreement with Witherspoon to ensure the Michigan Road property condition is maintained in a good condition for sale purposes. Second Girtha. Approved.

7/27/2023

PYOCA property transfer agreement – Judy Woods A. Transfer of the property to PYOCA Agreement with Department of Natural Resources (DNR). DNR has not signed off on the transfer yet; they have first right of refusal on the PYOCA property. Presbytery signed an easement agreement with DNR in three parts that refer to three parcels PYOCA is built on. This was for flood control purposes. It also says if the Presbytery ceases to own the property, the title would

switch immediately to DNR. Judy has negotiated a plan with DNR which does not need the governor's signature (as long as the only transfers are between the Presbytery and the new PYOCA board (PCRC).) If the new board should fail in the future, the property will revert back to the Presbytery to prevent being taken over by DNR. Paragraph 6 and 7: at closing all the deeds will have a reversionary clause. The property cannot be sold to any other entity. Judy would prefer to have the governor's signature, but will get a letter from DNR saying the agreement is fully binding on them. It is possible that a future State administration could view the agreement differently. Review by DNR will take 6 months (if the governor's signature were needed, it would take a year.) Paragraph 4: No cash will be exchanged with the property transfer, but there are considerations: a. Keeping the property in good condition at all times. Reporting could be made part of the granting of any Presbytery mission funds to PCRC. Presbytery does not have the right to an annual inspection. There are some protections: they can't dispose of any real property without Presbytery's authorization. WWVP and OVP will continue to have members on the board. b. Using the property in accordance with its past use with Presbyterian values. It will not be a Christian, Presbyterian, or religious camp. c. Indemnify and hold harmless the Presbytery from any legal claims, even if the Presbytery is named as a party of a future lawsuit. PCRC must report insurance coverage to Presbytery which is an "additionally insured." d. Reconvey the property to the Presbytery in accordance with the deed, in the event of any default by PCRC. B. Presbyterian churches that continue to use the camp, must be made aware that the Presbytery no longer owns the camp and that the new PCRC has its own legal coverages and policies, specifically policies concerning sexual misconduct, how staff are trained, etc. This will now be done outside of Presbytery policies and procedures. Motion to approve the transfer document and authorize Presbytery's attorneys to execute and finalize the documents and its exhibits for closing / transfer of the property from WWV.

First Presbyterian Church in New Castle was the organizing congregation for Westminster Community Center. It was spun off into its own non-profit. The property they are in is no longer suitable for their mission. That property has a reversionary clause in its deed, which would return the property to the Presbytery. Presbytery has done a property search to make sure there is no derogatory encumbrances that would keep the Presbytery from taking the property back. The director has asked to be given until the end of September to wrap up final operations. A motion to engage a broker, Dan O'Neil, to list the property. Alan and Eric will determine the correct timing for the listing, based on the request of the center director. Motion was made by Shawn and Bob seconded. MOTION passed.

10/19/2023

Michigan Road Property Sale Proceeds

Two components: Allocation of sale funds of Michigan Road; recommendation to Presbytery of the use of Presbytery's share. Sam and Eric shared a financial analysis that included an income / expense report and projection (for future costs and revenue). Witherspoon has drawn \$350,000 of \$500,000 loan. The bottom line is that Witherspoon would receive \$1.1 million and could decide for themselves how to address the PILP debt. BOD would advise that they pay off the PILP loan immediately. BOD would also advise that Witherspoon create an investment policy for investment of the net balance. For example, Presbytery could

partner with Witherspoon in creating an endowment. But the BOD should not dictate to Witherspoon what to do, but we should offer them resources for investments to consider. Shawn moved that 1) the analysis and remuneration of \$1.1 million to Witherspoon, 2) with the recommendation to retire the PILP loan as quickly as possible, and 3) that Presbytery stands available to help with resources for future investment vehicles that Witherspoon could take advantage of, be adopted. Sam seconded. MOTION passed.

The Presbytery should define an investment policy for the approximately \$1 million it will receive from this sale. Sam suggested putting out an RFP to New Covenant Trust Company (through PC(USA)) to put together an investment plan / portfolio for WWV Presbytery, based on their investment goals and target income stream. Most private investment companies do not handle portfolios this small, but Doug and Sam will investigate other companies who might respond to an RFP, e.g., Diamond Capitol of National Bank of Indianapolis, which Fairview uses for their similarly sized portfolio. Sam and Doug will report back at the end of November and give a recommendation for proposed action.

Charge to the Administrative Commission

For the Dissolution of Trinity Presbyterian Church, Fort Wayne, Indiana

By the Presbytery of Whitewater Valley

INTRODUCTION & BACKGROUND

The Trinity Presbyterian Church of Fort Wayne, Indiana, through its Session, have been in discernment and conversation for several months regarding the future of the congregation. The Session and church representatives have met with and sought the counsel of the Commission on Ministry's liaison and the Executive Presbyter. As the discernment continued, the Session from Trinity Presbyterian concluded that their season as a congregation had come to a close.

At a congregational meeting October 22, 2023 the Trinity Presbyterian congregation voted to hold their final worship and that their ministry would be complete.

In matters of dissolving a congregation, the attitude of the Presbytery of Whitewater Valley, from beginning to end, shall always be pastoral.

AUTHORITY

The responsibility and power to dissolve a congregation is granted to Presbytery by the Book of Order.

The COM believes the procedural dissolution of a congregation is best accomplished through an Administrative Commission. Therefore, the Commission on Ministry, in consultation with the Executive Presbyter and Stated Clerk, recommend approval of the following resolution:

RESOLVED: For the purpose of dissolving the Trinity Presbyterian Church of Fort Wayne, Indiana, the Whitewater Valley Presbytery appoints an Administrative Commission to act on Presbytery's behalf, effective November 1, 2023 with the following powers and functions for the purpose of dissolving the congregation in a timeframe required to complete the work:

- meet and consult with the former Session members to facilitate the work of the Commission;
- to arrange for the pastoral care of the members;
- to publicize the dissolution of the congregation;
- to ascertain the financial status and outstanding financial obligations of the congregation, secure the Session records, secure the legal rights to all property (real or personal) held by or for the benefit of the congregation;
- to dispose of the moveable personal property of the congregation, secure the building and property, attend to matters of insurance, dispose of the building and grounds (subject to the approval and/or concurrence by the Board of Directors) or convey the building and grounds to The Presbytery of Whitewater Valley, Inc.;
- to recommend to the Presbytery the use of the assets of the congregation;
- to assure that a Service of Witness is conducted and to participate in that service;

- to secure the assistance of other individuals, as appropriate, to assist with its work, and generally to do such things and take such actions for, in the name of, and on behalf of Whitewater Valley Presbytery as shall be reasonably necessary to accomplish the general purpose of this resolution;
- at the conclusion of its work, the report and recommendations of the Administrative Commission will be presented, when appropriate, to the Presbytery Assembly for action.

The funding related to the duties and functions of the Administrative Commission will be from the Presbytery's Corporate Funds.

Second Draft:

I believe in One, triune God who is Master Gardener, Creator, and Sustainer of all. I believe in the trinitarian nature of God known in three persons as God, Christ, and the Holy Spirit, equally sharing in divinity and power, yet distinct. I trust in the sovereign Creator who breathed life into the earth. With the dust of God's creation and God's own breath, humanity was created. The vision of new life was born. While God is ruler of all, God is also a companion and guide to humankind, God calls each of us into community with one another, knowing that all of creation is called good.

God's love for us, God's own beloved creation, is God's reason for sending God's only son on our behalf. Jesus the Christ was conceived by the Virgin Mary and the power of the Holy Spirit. Therefore, I believe Jesus is both fully divine and fully human. As the living incarnation of God sent to live among God's people, Jesus Christ acts as a physical and present reminder of the love and grace witnessed in the Word, the Holy Scriptures.

The works of our human lives do not justify this promise, but the promise is found in the sacrifice of Jesus alone.

I believe in the power and movement of the Holy Spirit. The Holy Spirit, sent by God and Christ, guides and encourages us through both the smallest, and the most grand gestures. The Holy Spirit is what guides us to emulate the love, compassion, hope, and healing of Jesus Christ that we are shown in the Holy Scriptures. The Holy Spirit not

only guides us toward a life more in tune with that of Jesus Christ, but it also gives us the talents and skills to use along the way. Each of us is touched by the Spirit and therefore pulled closer in relationship to God. The Holy Spirit is like the cement that holds the mosaic of the Christian family together. This Christian mosaic includes pieces that resemble Jesus Christ, God, the Holy Scriptures, and the body of believers. Together, with the glue of the Holy Spirit a beautiful image of love and hope prevails. Each piece of the mosaic creation needs the other; we need the comfort of God, the guidance and sacrificial promise of Jesus Christ, the Word of Scripture, the body of believers near and far, and the uniting glue of the Spirit creates a beautiful image where love and hope prevails.

I believe in the Sacraments of Baptism and the Lord's Supper. As physical reminders of the Trinity's presence and promise through the ordinary elements of water, bread, and wine. When we take part in the Sacraments, we are reminding ourselves of the commitment to claim our faith in God, Jesus, and the Holy Spirit.

I believe the Sacrament of Baptism reminds us God has called us into a relationship with God and the larger community of faith here on earth, before we even knew it. I believe the Sacrament of the Lord's Supper (or Holy Communion) acts as a reminder of the sacrifice made by Jesus for the forgiveness of our sins and the promise of a new life he gave to each of us. As we take part in this Sacrament, we are reminded that at God's table, all are welcome, loved, and sent forth as disciples of Christ.

I believe in the power of the Church. I trust in the Church's mission to bring forth the teachings and love of the Trinity in all that it does. We are called to be good neighbors to all in the world whether they look like us, believe in what we do, or share in the same values. We are the hands, feet, and mouths of God as members of God's Church. Therefore, we are called to promote love, peace, justice, and compassion for all of God's creation. I trust in God's calling in my life to lead this community in these ways, toward a world that is more kind and just in the image of God, the Son, and the Holy Spirit.

Biographical Statement for Jason Knapp

The Administrative Commission to Dissolve Immanuel Presbyterian Church of Indianapolis, Indiana

Introduction and Background

The Immanuel Presbyterian Church of Indianapolis, Indiana, its Session Moderator Rev. Bob Heimach, the Session, and the congregation engaged in a season of discernment for several months regarding the future of the congregation. The Session and church representatives sought the counsel of the Commission on Ministry and the Executive Presbyter. As the discernment continued, representatives from Immanuel Presbyterian initiated conversations with Witherspoon Presbyterian Church of Indianapolis to discuss how their active membership and leadership roles might be welcomed and honored. Both congregations concurred that the combined membership would elevate ministry and mission. At a congregational meeting on October 22, 2022, Immanuel Presbyterian Church voted to ask the Presbytery of Whitewater Valley to dissolve the congregation.

The responsibility and power to dissolve a congregation is granted to Presbytery by the Book of Order (G-4.0205) and for this purpose the Presbytery is able to appoint an Administrative Commission by Presbytery Standing Rules (#14, Commissions for Special Service). The Commission on Ministry believes the procedural dissolution of a congregation is best accomplished through an Administrative Commission.

For the purpose of dissolving the Immanuel Presbyterian Church, Indianapolis, Indiana, the Presbytery of Whitewater Valley voted at its Stated Meeting on Saturday, February 4, 2023 to appoint an Administrative Commission to act on Presbytery's behalf. The membership of the Administrative Commission is composed of the following individuals: Teaching Elder Karel Hanhart (Honorably Retired); Ruling Elder Joe Matthews (Immanuel Presbyterian, Indianapolis); Ruling Elder Martha McDonald (Irvington Presbyterian, Indianapolis); Ruling Elder Sandra Reid (Tabernacle Presbyterian, Indianapolis); and Teaching Elder Shelly Wood (Orchard Park Presbyterian, Carmel).

The Administrative Commission was granted the following powers and functions for the purpose of dissolving the congregation:

- Meeting and consulting with members of the Immanuel Presbyterian Session to facilitate the work of the Commission;
- Arranging for pastoral care of the members;
- Publicizing the dissolution of the congregation;
- Ascertaining the financial status and outstanding financial obligations of the congregation, securing the Session records, securing the legal rights to all personal property held by or for the benefit of the congregation;
- Recommending to the Presbytery the use of the assets of the congregation in consultation with the Immanuel Session;

- Assuring that a Service of Witness is conducted;
- Securing the assistance of tother individuals, as appropriate, to assist with its work, and generally to do such things and take actions for, in the name of and on behalf of the Presbytery of Whitewater Valley as shall be reasonably necessary to accomplish the general purpose of the resolution of its charge;
- Reporting actions and recommendations of the Administrative Commission to the Presbytery Assembly at the conclusion of its work.

Reported Actions of the Administrative Commission

- 1. The Commission went through files and records and transferred historical and membership records to the Presbytery for appropriate preservation.
- 2. The Commission identified members of the congregation who had not yet transferred membership to another congregation and informed them of Immanuel's closing date and instructions on how to transfer membership once they had identified a new church home.
- 3. The amount of outstanding per capita was determined and paid in full through the Presbytery.
- 4. The final worship service as a Service of Witness was scheduled to be held at Witherspoon Presbyterian Church on Sunday, July 16, 2023 at 3:00 p.m. with a reception afterward.

Recommendations to the Presbytery of Whitewater Valley

Remaining financial funds to be allocated as follows:

- a. \$12,000 --- current expenses
- b. \$10,000 Let's Chat 2 Fund
- c. \$10,000 Transportation Fund
- d. \$10,000 Glory of God
- e. Remainder of Immanuel Funds to be held by Witherspoon Presbyterian Church in a restricted fund under the oversight of former Immanuel Session members (Ruling Elder Joe Matthews, Ruling Elder Barbara Black; Ruling Elder Willis Bright)

Checking account to be closed on August 31, 2023. Final dissolution of the Immanuel Presbyterian Church to be accomplished by the appropriate Presbytery staff in collaboration with the Administrative Commission.

Report of the Administrative Commission Hope United Presbyterian Church Plainfield, Indiana Whitewater Valley Presbytery November 1, 2023

For the purpose of dissolving Hope United Presbyterian Church, Plainfield, Indiana, after a congregational vote on April 24, 2022, the Whitewater Valley Presbytery appointed an Administrative Commission to act on Presbytery's behalf, effective May 4, 2022, with the following powers and functions for the purpose of dissolving a congregation in a timeframe required to complete the work as specified below:

- Consult with remaining Session members to facilitate the work of the Administrative Commission;
- Arrange for pastoral care of congregation members;
- Ascertain the financial status and outstanding financial obligations of the congregation, secure Session records, secure the legal rights to all property (real and personal) held by or for the benefit of the congregation;
- Dispose moveable personal property of the congregation, secure the building and property, attend to matters of insurance, dispose of building and grounds and convey any proceeds to The Presbytery of Whitewater Valley, Inc;
- Recommend to the Presbytery the use of assets of the congregation;
- Plan and participate in a Service of Witness and to determine the effective dissolution date;
- Secure the assistance of any other individuals as appropriate to assist with the
 work of the Administrative Commission and take such actions in the name of and
 on behalf of the Presbytery of Whitewater Valley, as shall be reasonably
 necessary to accomplish the general purpose of this resolution and all other
 business and actions related to the dissolution of the congregation;
- Provide a written report of actions of the Administrative Commission at the conclusion of its work which will be presented to the Presbytery Assembly with dismissal of the Administrative Commission to follow.

The following is a summary of our work:

The first meeting of HUPC A/C was held on May 6, 2022 at the church; Ebbie Crawford was chosen as Moderator by consensus. Over the next two months, the A/C set out to secure all records, meet with Session members for input into future building/property usage, generate an inventory of contents for distribution and/or sale, and set a Date of Dissolution/Final Worship Service date of October 2, 2022.

In preparation for possible property sale, an Appraisal was ordered in March, 2022; the Appraisal amount came to \$890,000. It soon became clear, however, that the primary candidate preferred by HUPC Session was *Family Promise of Hendricks County*, a local agency which specializes in housing and supportive services of families. The A/C was also aware that *Family Promise* was unable to meet anywhere near the full retail amount of the building appraisal.

After much discussion about financial priorities, mission goals and meeting with the principal associates of the agency, the A/C invited *Family Promise* to make their "best offer" and, ultimately, agreed to their proposed offer of \$550,000, contingent on any zoning changes, on June 25, 2022. The sales agreement gave *Family Promise* sixty (60) days to finalize the deal. At the same time, HUPC Session offered to gift to other Presbyterian churches any contents that could continue to be used in Worship services.

Storm clouds began to gather almost immediately in the form of active opposition to *Family Promise* occupation in the neighborhood. Meanwhile, the zoning change application extended the time necessary to close the sale. The A/C and *Family Promise* hosted a neighborhood meeting in Hope UPC Sanctuary on August 23, 2022, in an attempt to address the rumors and concerns of the area residents. It did not go well.

After the Town of Plainfield Zoning Board voted to NOT recommend the zoning change application of *Family Promise*, their sales proposal was rescinded and the A/C began a different search for a possible buyer of the church building and premises. There had been numerous informal inquiries of various groups from the beginning of the A/C assignment; however, this time, the A/C decided to list the property with a commercial realtor for the best possible outcome.

Dan O'Neil of Berkshire Hathaway Realty was chosen after the A/C interviewed three total realtors in January, 2023. Dan was given the list of all interested parties who had contacted the A/C in the prior months; this time, the A/C agreed to list the property (as is) for \$1,125,000. There were several interested queries throughout the winter and early spring months.

By May, 2023, a Sikh organization, represented by Mr. Jaswinder Singh, agreed to all the A/C terms and signed a purchase agreement for Hope UPC for \$1,120,000 cash and "as is" condition. Closing occurred on June 20, 2023.

After all realty expenses (closing costs, realtor fee, etc) and all church obligations (remaining mortgage, utilities, contents disposal, etc) were satisfied, the Available

Disbursement Amount was revised to \$1,151,000.00. This amount included the remaining church funds after final expenses were paid and has been transferred to the Presbytery. The A/C now wishes the funds to be disbursed as follows:
